

## Revised Notice of Public Hearing

March 8, 2011 Ref. 2010-H-06 Revision 3

The Canadian Nuclear Safety Commission (CNSC) announces a revised deadline for the submission of requests to intervene on Hydro-Québec's application to renew and combine its operating licences for the Gentilly-2 nuclear reactor and its solid radioactive waste management facility in Bécancour, Québec. The deadline is **extended to March 21, 2011**. The supplementary submission filed by CNSC staff is available on request and the supplementary submission from Hydro-Québec will be available on March 10, 2011.

Under its current licences, Hydro-Québec is authorized to operate the Gentilly-2 Nuclear Generating Station and its waste management facility, to possess and handle certain nuclear substances and to carry out other activities described in the licences.

The first day of the hearing was held in Ottawa, Ontario on December 10, 2010. The continuation of the hearing is scheduled to be held in Bécancour, Québec.

The public hearing will be webcast live and the recording will be available for a period of 90 days on the CNSC Web site.

The public is invited to comment on Hydro-Québec's application on Hearing Day Two. Requests to intervene must be filed with the Secretary of the Commission by **March 21, 2011**, on-line at <a href="http://www.nuclear.safety.gc.ca/eng/commission/intervention">http://www.nuclear.safety.gc.ca/eng/commission/intervention</a> or at the coordinates below. Pursuant to the *Canadian Nuclear Safety Commission Rules of Procedure*, **the request must include the following information:** 

- a written submission of the comments to be presented to the Commission Tribunal
- a statement setting out whether the requester wishes to intervene by way of written submission only or by way of written submission and oral presentation
- the name, address and telephone number of the requester

Personal information such as the address and telephone number is essential for confirming the link between the submission and its author. If you want your personal information to remain



confidential, please submit it on a separate page. The public may access all submissions by making a request to the Secretariat.

Hydro-Québec's submissions and CNSC's staff recommendations that were filed for the public hearing of December 10, 2010 are available on request to the Secretariat.
