

Revised Notice of Public Hearing

May 4, 2011

This revised notice provides more detailed information on the nature of Canadian Light Source Inc. (CLSI)'s application. The Canadian Nuclear Safety Commission (CNSC) will hold a one-day public hearing to consider CLSI's application to amend its Particle Accelerator Operating Licence to refer to the updated CLSI Quality Manual and to modify the occupancy and the access control to Experimental Area 2 (EA2) to prepare the area for the installation of a linear accelerator for the production of Molybdenum-99, a medical isotope. CLSI is located in Saskatoon, Saskatchewan.

The public hearing will be webcasted live on the Internet via the CNSC Web site and archived for a period of 90 days.

CLSI requests CNSC's approval for their Quality Manual which has been restructured and reformatted. CLSI also requests approval for the modification of the occupancy and the access control to area EA2 for the purpose of installation of the medical isotope project to produce Molybdenum-99. The medical isotope project includes the installation and operation of an electron linear accelerator and the design, installation, commissioning and operation of a supporting nuclear materials laboratory.

The public is invited to comment on CLSI's application. Requests to intervene must be filed with the Secretary of the Commission by May 9, 2011 directly on-line at http://www.nuclearsafety.gc.ca/eng/commission/intervention/index.cfm or at the coordinates below. **The request must include the following information**, as per the *Canadian Nuclear Safety Commission Rules of Procedure*:

- a written submission of the comments to be presented to the Commission;
- a statement setting out whether the requester wishes to intervene by way of written submission only or by way of written submission and oral presentation; and
- name, address and telephone of the requester.

Personal information, such as address and telephone numbers, is essential for linking the submission to its author. Please submit your personal information on a separate page if you wish



to ensure its confidentiality. It should be noted that all submissions are available to the public upon request to the Secretariat.

CLSI's submission and CNSC staff's recommendations to be considered at the hearing will be available after April 8, 2011. These documents are not downloadable. To obtain them, a request must be made to the Secretariat at the address below or directly from the Web site.
