



Notice of Public Hearing

The Canadian Nuclear Safety Commission (CNSC) will hold a two-day public hearing on the application by Cameco Corporation (Cameco) to renew its Nuclear Fuel Facility Operating Licence for Cameco Fuel Manufacturing Inc. located in Port Hope, Ontario. Cameco has requested a 10-year licence term.

The current licence authorizes Cameco to operate Cameco Fuel Manufacturing Inc. to manufacture fuel element bundles using zircaloy tubes containing uranium dioxide (UO₂) pellets for use as nuclear fuel primarily in CANDU reactors. The current licence also provides continued authorization to process and store depleted UO₂ and limited quantities of low enriched UO₂.

The public hearing will be webcasted live on the Internet via the CNSC Web site and archived for a period of 90 days.

The public is invited to comment on Cameco's application. Requests to intervene must be filed with the Secretary of the Commission by December 19, 2011 directly on-line (<http://www.nuclearsafety.gc.ca/eng/commission/intervention/index.cfm>) or at the coordinates below. Pursuant to the *Canadian Nuclear Safety Commission Rules of Procedure*, **the request must include the following information:**

- a written submission of the comments to be presented to the Commission;
- a statement setting out whether the requester wishes to intervene by way of written submission only or by way of written submission and oral presentation; and
- name, address and telephone of the requester.

Personal information, such as address and telephone numbers, is essential for linking the submission to its author. Please submit your personal information on a separate page if you wish to ensure its confidentiality. It should be noted that all submissions are available to the public upon request to the Secretariat.

The CNSC has [announced the availability of funding](#) under its Participant Funding Program to assist interested parties in reviewing and commenting on the 10-year licence renewal for Cameco Fuel Manufacturing Inc. Participant funding will be considered for the provision of new, distinctive and valuable information to the CNSC through informed and topic-specific interventions.
