## Ontario Power Generation Application for the Renewal of the Licence for the Darlington Waste Management Facility

Following a hearing on December 3-6, 2012, the Canadian Nuclear Safety Commission (CNSC), pursuant to section 24 of the *Nuclear Safety and Control Act*<sup>1</sup>, renewed Ontario Power Generation (OPG)'s Waste Management Operating Licence for its Darlington Waste Management Facility located in Darlington, Ontario. The renewed licence, WFOL-W4-355.00/2023, is valid from March 13, 2013 to April 30, 2023.

The previous licence, WFOL-W4-355.00/2013, expires on April 30, 2013. The following changes are made in order to avoid any confusion on the status of this previous licence.

The following changes are made to the English version of the *Record of Proceedings* document issued on March 13, 2013 by the Canadian Nuclear Safety Commission, pertaining to OPG's application for the renewal of the licence for the Darlington Waste Management Facility.

1. On page 3 of the document, paragraph 10, the paragraph in the decision box

"the Commission, pursuant to section 24 of the Nuclear Safety and Control Act, renews Ontario Power Generation's Waste Management Operating Licence for its Darlington Waste Management Facility located in Darlington, Ontario. The renewed licence, WFOL-W4-355.00/2023, is valid from March 13, 2013 to April 30, 2023."

is changed to

"the Commission, pursuant to section 24 of the Nuclear Safety and Control Act, renews Ontario Power Generation's Waste Management Operating Licence for its Darlington Waste Management Facility located in Darlington, Ontario. The renewed licence, WFOL-W4-355.00/2023, is valid from March 13, 2013 to April 30, 2023. **By this decision, the Commission replaces the former licence with the renewed licence**."

2. On page 39 of the document, paragraph 226, the paragraph

"Therefore, the Commission, pursuant to section 24 of the *Nuclear Safety and Control Act*, renews Ontario Power Generation's Waste Management Operating Licence WFOL-W4-355.00/2013 for its Darlington Waste Management Facility (DWMF) located in Darlington, Ontario. The licence, WFOL-W4-355.00/2023, will be valid from March 13, 2013 to April 30, 2023. This decision includes the authorization to construct and operate two additional waste storage buildings after the completion and approval of the EA."

The licence, WFOL-W4-355.00/2023, will be valid from March 13, 2013 to April 30, 2023. By this decision, the Commission replaces the former licence with the renewed licence. This decision includes the authorization to construct and operate two additional waste storage buildings after the completion and approval of the EA."
