## Notice of Public Hearing and Participant Funding

The Canadian Nuclear Safety Commission (CNSC) will hold a public hearing to consider an application from Cameco Corporation (Cameco) to renew, for a period of 10 years, its Nuclear Fuel Facility Operating Licence for the Port Hope Conversion Facility located in Port Hope, ON. The current licence expires February 28, 2017.

Date: November 9–10, 2016

The public hearing will be webcast live and archived for 90 days on the CNSC website at nuclearsafety.gc.ca.

Through its Participant Funding Program, the CNSC is offering up to \$50,000 in funding to assist members of the public, Aboriginal groups and other stakeholders in reviewing Cameco's application and associated documents, and participating in the Commission hearing process by providing topic-specific interventions to the Commission.

The deadline for submitting a completed participant funding application form to the CNSC is **June 30, 2016**.

Additionally, members of the public who have an interest or expertise in this matter or information that may be useful to the Commission in coming to a decision are invited to comment on Cameco's application. Requests to intervene must be filed with the Commission Secretary by October 3, 2016 using the online request form at <a href="mailto:nuclearsafety.gc.ca/eng/the-commission/intervention">nuclearsafety.gc.ca/eng/the-commission/intervention</a> or following the coordinates below. Pursuant to the Canadian Nuclear Safety Commission Rules of Procedure, the request to intervene must include the following information:

- a written submission of the comments to be presented to the Commission
- a statement setting out whether the requester wishes to intervene by way of written submission only or by way of written submission and oral presentation
- the name, address and telephone number of the requester



All submissions are available to the public upon request to the Secretariat. Personal information, such as address and telephone number, is essential for linking the submission to its author. If you wish to ensure the confidentiality of your personal information, please submit it on a separate page.

Cameco's submission and CNSC staff's recommendations to be considered at the hearing will be available after **September 2, 2016**. These documents are not available online.
