<ul> <li>Impala Canada Ltd. can demonstrate, to the written satisfaction of CNSC staff, that:</li> <li>1. They have revised the vessel/hopper entry procedures in their radiation protection program in order to comply with all requirements of Licence Condition 2052, and have amended their licence to include these revised procedures.</li> <li>2. They have implemented a system of record keeping to demonstrate compliance with vessel/hopper entry procedures, including all requirements specified in Licence Condition 2052, and to ensure adequate management oversight over the procedures.</li> <li>3. They have developed a training program for workers who are required to perform vessel/hopper entries, including any external contractors.</li> <li>4. They have trained all workers who are currently authorized to perform vessel/hopper entry activities.</li> </ul>

<ul> <li>6. Information on which order is based</li> <li>1. The Radiation Safety Officer (RSO) had no knowledge of vessel entries performed in 2023, which points to a lack of management oversight over the procedure. During a routine compliance inspection of the licensee on October 16, 2023, the RSO stated that there have been no vessel entries since the last inspection. However, the inspector had some concerns that the RSO may not be notified of vessel entries, especially because the signage on the vessel was inadequate (no radiation warning sign or requirement to follow procedures). In the special remarks section of the Preliminary Inspection Report, the inspector made the following request:</li> <li>"Please verify that there have been no entries into the crusher apron feeder since 2018 (from either side of the vessel)."</li> <li>In his corrective measures, the RSO states that they have identified 2 instances in 2023 where the vessel has been entered, and provides the "Nuclear Source Lock-out: Survey Meter Record" form for both.</li> <li>2. There are significant deficiencies in the records provided for vessel entries on September 8, 2023 and April 12, 2023.</li> <li>See ADDENDA for more information.</li> </ul>
