- 1. Cameco Corporation wishes to have prohibited from public disclosure the following documents:

- 3. The information contained in the above-referred document(s) should be **prohibited** pursuant to paragraph **12(1)(b)** of the CNSC Rules of Procedure for the following reasons:

Cameco considers the above referenced documents to be confidential and proprietary in their entirety, as they contain confidential information of a financial, commercial, scientific, technical, personal or other nature that is treated consistently as confidential and, in the case of personal

information, the person affected has not consented to the disclosure. More specifically, the information contained in the above-referenced documents listed above consist of:

- (i) confidential commercial, financial and technical information that is consistently treated as confidential by Cameco and was provided by Cameco to the CNSC.
- (ii) employee names, titles and signatures, which are considered personal information.

Additionally, the disclosure of this information could reasonably be expected to prejudice Cameco's competitive position, as the above-referenced documents provide details of Cameco's business practices, including the rationale underlying cost estimates and assumptions, related to preliminary decommissioning planning and cost estimating that would be beneficial to Cameco's competitors.

- 4. The information sought to be **prohibited** is being provided to the CNSC in confidence, and is to be received in confidence by the CNSC.
- 5. The information sought to be **prohibited** is not available in public sources, to the best of my knowledge and belief.

For all the reasons discussed above, **Cameco Corporation** requests that the identified confidential information be **prohibited** from public disclosure.
