

# Notice of Request for Confidentiality

September 5, 2024 CMD 24-H3

Pursuant to Rule 12 of the Canadian Nuclear Safety Commission Rules of Procedure, Ontario Power Generation Inc. (OPG) has requested that information associated with the following matter be kept confidential:

## OPG's application for a licence to construct 1 BWRX-300 reactor for its Darlington New Nuclear **Project**

The Canadian Nuclear Safety Commission (CNSC) is seeking comments from the public on the requests. Details on this public hearing can be found in the notice of public hearing.

#### Requests for confidentiality

OPG has submitted 4 related requests for confidentiality on this matter:

- 1. Request for confidentiality of material submitted in relation to NK054-CORR-00531-10740, Darlington New Nuclear Project - Submission of Package #3 Security Deliverables in Support of the Licence to Construct Application for the CNSC Review
- 2. Request for confidentiality of material submitted in relation to CMD #24-H3.1, OPG Written Submission in Support of the Darlington New Nuclear Project Application for a Power Reactor Construction Licence
- 3. Request for confidentiality of material submitted in relation to CMD #24-H3, CNSC Staff Review and Assessment of OPG's Application for a Licence to Construct a BWRX-300 Reactor at the Darlington New Nuclear Project Site
- 4. Request to protect confidential information in the matter of NK054-CORR-00531-10775, Darlington New Nuclear Project – Submission of Package #6b Construction and Commissioning Program Confidential Deliverables in Support of the Licence to Construct Application for the CNSC Review

The requests also contain non-confidential summaries or redacted versions of the documents for which OPG has requested confidentiality. Prior to the hearing, the Commission will render a decision under Rule 12 on what measures, if any, are to be taken to protect the confidential information. In making its decision, the Commission will consider OPG's requests along with any comments received from other interested parties.



#### To comment on this request

Interested parties who want to comment on this request for confidentiality are invited to file a written submission with the <u>Commission Registry</u> explaining:

- a. why the material should or should not be made public
- b. why the available or proposed non-confidential material is or is not sufficient
- c. if applicable, the specific information that should be made available to the public, and why

Comments on the request for confidentiality must be filed with the Commission Registry no later than September 20, 2024.
