Re: Intervention for CNL CNSC Hearing – PGP Liquid Effluent Release Limits

This memo is to support The Municipality of Clarington (“The Municipality”) for an intervention to the Canadian Nuclear Safety Commission (“CNSC”) for the Canadian Nuclear Laboratories (“CNL”) public hearing on March 22, 2019 to amend the release limits of liquid effluent (“release limits”) in its Waste Nuclear Substance Licence for the Port Granby Long-Term Low-Level Radioactive Waste Management Project (Port Granby Project).

The Municipality is continuously provided scheduled monthly updates at a Project Coordination Meeting, as well as communications as needed in between the meetings. As such, the Municipality was informed of the proposed release limits several months ago. The values that have been provided in CNL’s hearing documentation CMD 19-H101.1, as well as the CNSC’s hearing documentation CMD 19-H101, match the values that were provided to The Municipality.

The Municipal Peer Review Team (“MPRT”) reviewed the proposed effluent release limits and did not have any major concerns with the values. Therefore, the MPRT do not have concerns with the application of these release limits.
