We are writing to you today on behalf of the Ontario Association of Demolition Contractors (OADC), in support of the recommendation to the Canadian Nuclear Safety Commission (CNSC) to approve the Canadian Nuclear Laboratories Limited (CLN)'s submission. This submission pertains to the amendment of the Douglas Point Waste Facility (DPWF) Decommissioning Licence to proceed with Phase 3 Decommissioning involving dismantling and demolition of all remaining facilities of the DPWF.
