## **CNSC to conduct hearing in writing to review Cameco Corporation's updated financial guarantee for the Rabbit Lake Operation**

The Canadian Nuclear Safety Commission (CNSC) will conduct a public hearing based on written submissions in fall 2025. The hearing in writing is to review the updated financial guarantee for the Rabbit Lake Operation owned and operated by Cameco Corporation (Cameco). The Commission will be deciding whether to accept Cameco's updated financial guarantee. **This revised notice of hearing in writing is being issued to amend the date for the filing of the submission from CNSC staff. CNSC staff's submission will be available after October 22, 2025.**

Cameco's Rabbit Lake Operation is located approximately 750 km north of Saskatoon, Saskatchewan. It is situated within Treaty 10 (1906) territory, the Homeland of the Métis, and the traditional territories of the Denesųłiné, Cree and Métis Peoples.

According to its uranium mine and mill licence, Cameco is required to maintain a financial guarantee for decommissioning that is acceptable to the Commission. The current financial guarantee was accepted by the Commission in [March 2021](#).

CNSC [REGDOC-3.3.1, Financial Guarantees for Decommissioning of Nuclear Facilities and Termination of Licensed Activities](#), requires licensees to periodically review and revise their financial guarantees. Cameco submitted an updated preliminary decommissioning plan and revised financial guarantee to the CNSC in 2024.

Pursuant to rule 3 of the [Canadian Nuclear Safety Commission Rules of Procedure](#) (the Rules), the Commission has decided to vary the Rules in order to ensure that this hearing is dealt with as informally and expeditiously as the circumstances and the considerations of fairness permit. The Commission will consider a written submission from CNSC staff. A panel of the Commission will then deliberate and render a decision on this matter. A decision from the Commission is anticipated in **fall 2025**. A record of decision will be published on the [CNSC website](#) and made available on request to the Commission Registry.
