**Pickering NGS – Request to Extend Deadline Under PROL 48.01/2028 Licence Conditions 15.1 and 15.4 Related to the End of Commercial Operation**

The purpose of this letter is to request extension of the deadline specified under PROL 48.01/2028 Licence Conditions 15.1 and 15.4 to extend the end of commercial operation. Based on the announcement made by the Ontario Minister of Energy on September 29, 2022, OPG is requesting additional time to complete the re-assessment required to meet these Licence Conditions for operation of Units 5-8 into 2026.

OPG recognizes the regulatory requirements and expectations regarding the operation of the Pickering Nuclear Generating Station beyond December 31, 2024 as established in the Pickering Power Reactor Operating Licence, PROL 48.01/2028.

The requirements for operation of the Pickering NGS beyond this date were documented in the associated Record of Decision. Licence Conditions 15.1 and 15.4 include a requirement to notify the CNSC in writing of the intent to operate beyond 2024 and to re-assess the continued validity of the Periodic Safety Review (PSR) and provide the results to the CNSC staff, no later than December 31, 2022. Also, the application to operate Pickering beyond December 31, 2024, is due to the Commission by the end of 2022.

OPG is requesting to extend the deadline for the reassessment of the continued validity of the PSR results as well as the application deadline to June 30, 2023, with the intent to notify the CNSC of the final end of commercial operation dates of all Pickering units by December 31, 2022. These dates would change the date requirements of Licence Conditions 15.1 and 15.4, but sufficient time would remain to provide the information for a public hearing.

In Reference 1, OPG informed the CNSC of the intent to pursue approval for operation of Pickering units 5-8 beyond December 2024. OPG continues to

communicate with CNSC staff and engage staff in reviewing the deliverables under the re-assessment of the PSR, including the fitness for service of major components, such as fuel channels, to ensure that the PSR reassessment will be accepted.

OPG is requesting a response to this request to extend the due date for Licence Conditions 15.1 and 15.4 by October 30, 2022.
