1.0 IDENTIFIED INDIGENOUS NATIONS AND COMMUNITIES

The lands and waters on which the Darlington New Nuclear Project (DNNP) is situated are within the traditional and treaty territory of the Williams Treaties First Nations (WTFNs), which includes Curve Lake, Hiawatha, Alderville, Chippewas of Beausoleil, Chippewas of Georgina Island, Chippewas of Rama First, and the Mississaugas of Scugog Island First Nations.

In 1923, the Chippewa First Nations and the Mississauga First Nations signed the Williams Treaties and together, over 90 years later in June 2018, these Nations joined to ensure that their rights to and the relationship with these lands is respected through a renewed agreement with Canada and the Province of Ontario.

Other Indigenous Nations and communities that have expressed interest in the project or who have been identified for engagement by the Crown include: Mohawks of the Bay of Quinte (MBQ), Métis Nation of Ontario Region 8 (MNO8), Kawartha Nishnawbe, Six Nations of the Grand River, the Saugeen Ojibway Nation and the Huron Wendat. OPG is prepared to discuss the DNNP with any interested Indigenous Nation or community.

OPG acknowledges the inherent, Aboriginal and treaty rights of Indigenous Nations and communities as recognized in the Constitution Act, 1982. OPG’s Indigenous Relations policy provides a framework for engaging with Indigenous peoples, advancing reconciliation and to regularly reporting on the company’s activities and progress in achieving established goals.

The purpose of this Indigenous engagement report is to document Indigenous engagement activities related to DNNP, to track issues and concerns raised, as well as steps that OPG has taken to minimize impacts or to address issues raised. This report is prepared in accordance with REGDOC-3.2.2, Indigenous Engagement.

OPG’s objective with respect to engagement with interested Indigenous Nations and communities is to share information on DNNP, understand concerns and potential impacts to Aboriginal and Treaty rights, promote dialogue and create collaborative opportunities for participation in the development, implementation, and review of mitigation measures. This engagement must be built on a relationship that includes trust and respect to be meaningful.

OPG has offered capacity funding agreements to all the WTFNs. To date agreements are in place with Curve Lake, Mississaugas of Scugog Island, and Hiawatha First Nations. Very early discussion have recently begun with Alderville First Nation. Capacity funding has also been provided to other Indigenous communities based on submitted costs and expenses, such as the Metis Nation of Ontario Region 8.

The Indigenous Nations and communities included in the engagement program related to DNNP is listed in Table 1.

2.0 SUMMARY OF ENGAGEMENT ACTIVITIES MARCH 2023 – NOVEMBER 2023

In 2020, OPG submitted an Indigenous Engagement Report to the CNSC as part of the Power Reactor Site Licence renewal application that covered the period of November 2018 to March 2020 [R3].

Subsequently, in October 2022 and March 2023, [R6] and [R7] respectively, OPG provided updated Indigenous Engagement Reports to provide progressive updates on the most recent engagement activities.

With this Revision, OPG is providing an update on engagement activities for the period March 2023 to November 2023. The detailed log of engagement activities over this period is provided in Table 2.

Highlights for this reporting period include:

- The OPG Indigenous Relations and Partnerships Department is in discussions with representatives of the Williams Treaties First Nations to develop a pathway forward that includes a scoping exercise in Q1 2024 to begin to develop a plan to undertake an Indigenous Knowledge

Study, which could include or lead to a cumulative effects study, a rights impact assessment and opportunities to identify and address the options for extended environmental engagement, based on a gap analysis which would compare standards from the 2009 EA to the standards of today.

- All Project staff have or will in early 2024 participate in mandatory cultural competency training with a focus of the William Treaties First Nations.
- The Indigenous Opportunities Network program placed 30 Indigenous candidates in union and non-union roles in 2023; a total of 123 since the program began in 2018. In 2024, ION will connect with the SMR-X partners to increase the number of placements.

Engagement is primarily led by dedicated DNNP Indigenous Engagement staff, with support of other subject matter experts in the project. SON engagement related to any planned Western Waste Facility is led by Nuclear Sustainability Services as per W-PLAN-00520-00001 [5]. In addition, OPG's Indigenous Relations staff engage with the Nations and communities on matters related to other projects and operations, and they also support DNNP engagement activities.

As engagement continues and the project progresses, areas of interest to Indigenous Nations and communities will be targeted along with any areas that are identified as having potential impacts to Inherent and Treaty Rights. These include:

- Archeological planning and findings, potential for repatriation of artifacts
- Potential impacts to hunting and other harvesting rights
- Management of nuclear waste streams
- Impacts to the lake and land and the effect on plant, animal, and aquatic species, with particular interest in bio cultural species identified
- Emissions to air and water, including thermal plume effects
- Incorporation of Indigenous Knowledge and ceremony into the Project
- Opportunities for employment, businesses, and investment, e.g., ION Program

4.0 PROPOSED SCHEDULE FOR INTERIM REPORT TO CNSC

Currently, CNSC and OPG engage in monthly meetings to discuss OPG operations and projects and how these interact with Indigenous Nations and communities. The DNNP Project is a regular agenda item on this call. The frequency of these contacts can be increased as needed.

OPG will provide updated reports to support Commission Member Documents as part of ongoing planned licensing activities.

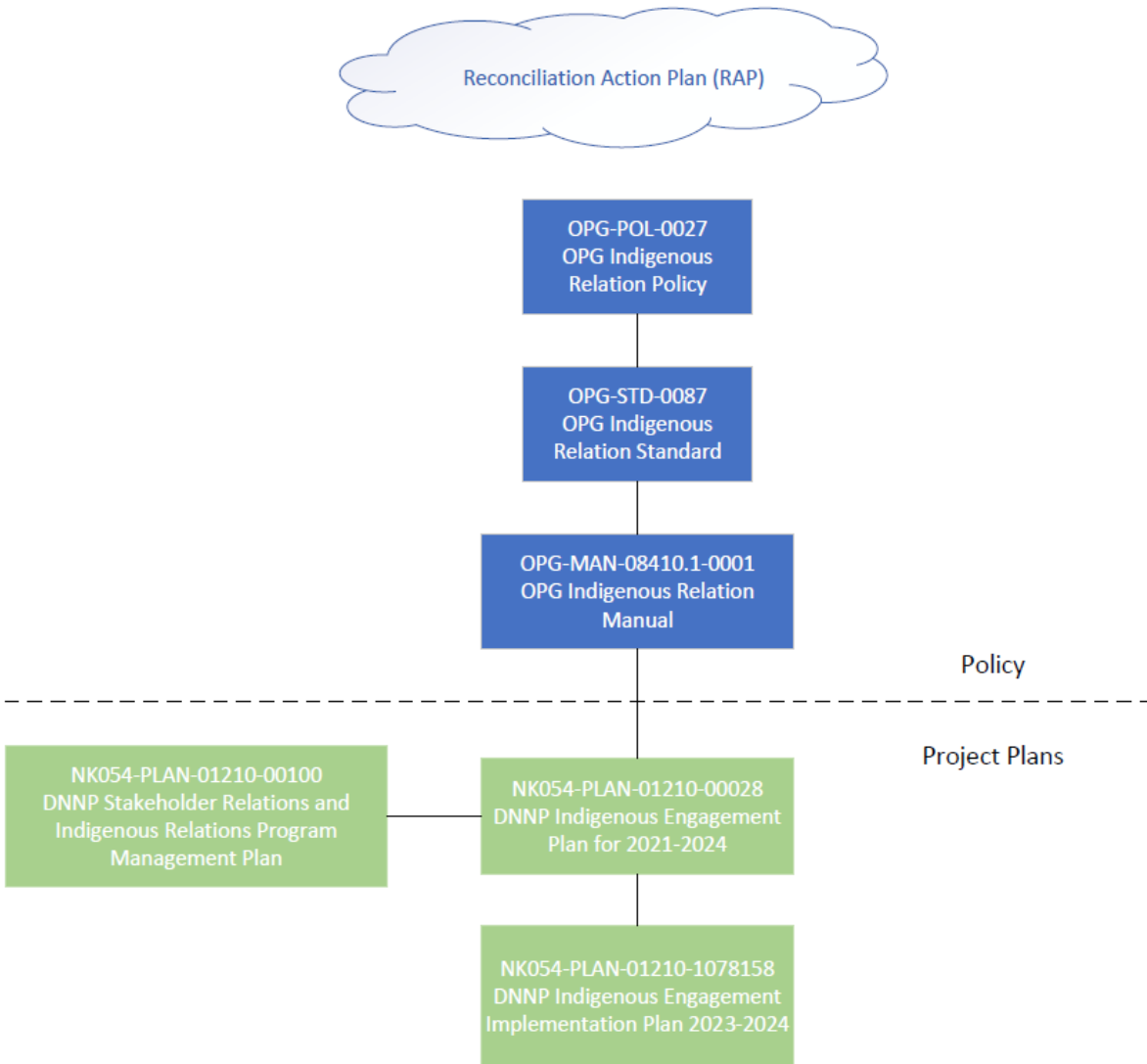
