Re: Commission Expectations for Part 2 of the Hearing on OPG's Application for a Licence to Construct one BWRX-300 Reactor for the Darlington New Nuclear Project

Dear Sarah Eaton,

The purpose of this letter is to inform CNSC staff of the Commission's expectations for Part 2 of the hearing on OPG's application for a licence to construct one BWRX-300 reactor for the Darlington New Nuclear Project (DNNP). Part 2 of the hearing is scheduled in January 2025.

INSTRUCTION

With respect to Part 2 of the hearing, the Commission directs CNSC staff to provide a detailed presentation that includes the following information:

- a sufficient overview of CNSC staff's regulatory review of OPG's application, for the benefit of hearing participants and observers who may not have seen Part 1 of the hearing
- a thorough explanation of CNSC staff's position as to why, from a regulatory perspective, the current state of the design and safety case are acceptable to support staff's recommendation to issue a licence to construct

The above information should be given and explained in plain language for the benefit of hearing participants and observers.
