Dear Members of the Canadian Nuclear Safety Commission: On behalf of our members and Board of Directors,

I am writing today to express wholehearted support from the Greater Oshawa Chamber of Commerce for Ontario Power Generation's (OPG) license amendment for continued operations of Pickering Nuclear Units 5-8 to the end of 2026. The Greater Oshawa Chamber of Commerce represents and is the voice of business for over 700 Members.

Ontario Power Generation is one of largest employers in Durham Region with highly educated and skilled job opportunities now and in the future. They are a strong economic driver in Durham Region through their operations, projects, and leadership in community building organizations.

In all our dealings with OPG directly and indirectly, we have found it to be a safe, productive, and engaged operator, with a strong connection to its community through both its actions and ongoing communications of all decisions. We are particularly impressed with OPG's commitment to safety in all it does, and in its employee injury rate that is among the best in the world for its industry, and with the overall performance of the station. In 2023, Pickering nuclear recorded its second-highest output in the history of the six-unit station. In 2022, all six operating units ran simultaneously to supply energy for 109 consecutive days, a station record. In 2020, Pickering's Unit 4 experienced a record consecutive run of 730 days. Both feats are a testament to the station's continued reliability. Finally, we believe the Pickering station plays an important role in providing clean, safe, and reliable electricity for Ontario and Durham Region. The additional months of operations from Pickering Units 5-8 through to the 2026, is particularly critical given the extensive refurbishment projects under way for the Darlington and Bruce generating stations. While this important work is under way, there will be increased demands on the overall energy production plans in Ontario and Pickering's operations are essential to meeting those demands and providing baseload power for the province during that time.
