Thank you for giving us the opportunity to intervene for this public hearing. We are submitting this intervention on behalf of the North American Young Generation in Nuclear (NAYGN) – Durham Chapter in support of the application from Canadian Nuclear Laboratories (CNL) Ltd. for 3-year renewal of its nuclear research and test establishment decommissioning licence for the Whiteshell Laboratories site.
