

#### Dear Shawn Harriman:

The Saskatchewan Ministry of Environment (ministry) has reviewed the Cameco Corporation (Cameco) Rabbit Lake Operation October 21, 2025 submission (GDS 10067346), "Rabbit Lake Operation Preliminary Decommissioning Plan" and "Rabbit Lake Operation Preliminary Decommissioning Cost Estimate". This letter relates to the ministry's review of the Preliminary Decommissioning Plan (PDP) and Preliminary Decommissioning Cost Estimate (PDCE), dated December 2022 and originally submitted as General Document Submission 10058337. Based on this review, the ministry has the following understanding:

- Cameco has updated the Preliminary Decommissioning Plan (PDP) and Cost Estimate (PDCE) to address all ministry comments identified in the ministry letter dated September 3, 2024 (A. Rempel to S. Harriman).
- Cameco has sent two versions of the PDP and PDCE to the ministry and the Canadian Nuclear Safety Commission (CNSC) for final approval a version of each document with the changes tracked and a version of each document with the changes accepted.
- Based on the comments provided by the ministry as noted above, the Rabbit Lake PDCE is estimated to be \$295.8 million. The ministry finds the cost estimate of \$295.8 million acceptable. Once the Ministry has received the updated financial assurance instruments to align with the revised cost estimate, the ministry will consider Condition 8.2 of Approval to Operate PO22-002 fulfilled.
