## Commission Ruling on Request to Protect Confidential Information

**Requestor:** NexGen Energy Ltd.

**Matter:** 25-H12 — Application for a Licence to Prepare Site and Construct the Rook I Uranium Mine and Mill Project

**Proceeding:** Two-Part Public Hearing in November 2025 and February 2026

With respect to the matter noted above, the Commission has considered a [request for confidentiality](#)<sup>1</sup> from NexGen Energy Ltd. (NexGen) for the 2 documents set out in Table 1, below. This request was made pursuant to rule 12 of the [Canadian Nuclear Safety Commission Rules of Procedure](#) (the *Rules*).

In its consideration of NexGen's request for confidentiality, the Commission also considered [CNSC staff's review](#)<sup>2</sup> of NexGen's request.

The Commission's ruling on this request, for the purposes of this proceeding, is also documented in Table 1.

The Commission is satisfied that:

- as per subrule 12(1)(b) of the *Rules*, both documents in Table 1 contain confidential information of a financial, commercial, scientific, or technical nature that are treated consistently as confidential; and
- as per subrules 12(2)(a) and 12(2)(b) of the *Rules*, protection of the information outweighs in importance the public interest in public hearings and disclosure of evidence, and the measure taken is designed so as not to affect the public nature of the proceeding except to the extent necessary to adequately protect the information.

Therefore, applying subrules 12(3)(b) and 12(3)(c) of the *Rules*, the Commission orders that the publication or disclosure of information given to the Commission in both documents be prohibited, as described in Table 1.
