On behalf of the NSBA – Saskatoon’s Business Association and our more than 700 member businesses across Saskatoon and northern Saskatchewan we are pleased to submit this letter of support for NexGen Energy Ltd.’s proposed Rook I Project, currently before the Canadian Nuclear Safety Commission for approval.

The NSBA represents a diverse cross-section of businesses that contribute to Saskatoon’s regional economy, supply chains, and workforce. While the Rook I Project is located in Northern Saskatchewan, its economic and social benefits will extend well beyond the immediate project footprint and into designated Local Priority Areas (LPAs), including Saskatoon and surrounding regions.
