Saskatchewan's mining sector—particularly uranium—plays a critical role in supporting high-quality jobs, regional development, and Canada's position as a reliable global supplier of critical minerals for clean energy.

NexGen Energy Ltd.'s 100%-owned Rook I Project in northern Saskatchewan is seeking:

1. Approval of the Environmental Assessment under the Canadian Environmental Assessment Act, 2012 (CEAA 2012).
2. A License to Prepare a Site for and Construct a Uranium Mine and Mill under the Nuclear Safety and Control Act.

The Rook I Project will generate long-term economic growth and employment in northern Saskatchewan. Through environmental, geotechnical, and community assessments, this world-class uranium Project has designed a development plan that harmonizes economic growth with environmental and social responsibility.
