Introduction:

I am pleased to introduce myself today. My name is Raymond Laliberte, I am Metis and our family was raised in the Metis Community of Buffalo Narrows. My wife and our family continue to reside in Buffalo Narrows while guiding and helping to raise our two beautiful grandchildren.

In my opinion, I believe my contribution & dialogue today will be useful to the CNSC coming to a decision on this very important matter. I have learned by being totally immersed in our Metis Identity, Culture and Ways of Knowing for my life with guidance & teaching from our Elders. In addition, based on my Metis Knowledge of our Distinct Buffalo Narrows, Community I would be considered a Governance & Administration Knowledge Keeper. Additional, lived experience was gained while working with many jurisdictions and dealing with various community issues through my volunteer work with National, Provincial and Community agencies such as the elected Buffalo Narrows Municipal Mayor and Public NLSD 113 Education Board regional representative.

Currently, I have the pleasure of serving our BN Metis Citizens as the President of MN-S Buffalo Narrows – Metis Community Council (BN-MCC), Local #62.

MN-S BN-MCC, Local #62 is part of CWCL NR 2 Governance and a signature on the NexGen- CWCL NR2 Impact Benefit Agreement signed on June 15, 2023. The NexGen Rook 1 Project activity is geographically and directly connected by Saskatchewan Provincial Highway #155 to Buffalo Narrows which goes over our kiezle channel bridge, down our main street through our business district, pass

our school, recreation centre and directly adjacent to our community primary water source & supply.

Metis Way of Life: "How it was?"

I will take a few minutes to explain my experience while growing up in Buffalo Narrows.

Early in my generation as a baby boomer, we had extreme inadequate and overcrowded housing, no furnaces, no sewer or water infrastructure, no lawns, no fences, no telephone and no television. Our parents usually worked seasonal and during the summer season, we ran & played all summer with no shoes. In hindsight and in my opinion, we dealt with many issues including Systemic Racism; Denial of Fundamental Human Rights; Colonization; Metis Residential School and Forced Assimilation and the Impact was shown through many social determinants of health indicators such as high incarceration; high school drop out; mental health & addictions issues; family violence, child apprehension; high cost of living and a general loss of hope and sense of belonging.

Generally speaking, we suffered and were negatively impacted but never knew the difference and I thought everyone lived like us. We were unaware of our Metis identity, culture and rights and the public school system never taught us otherwise. As a Metis Community we were invisible to authorities, had no recognized rights, were in dire straits and primarily left to "manage poverty".

However, thanks to our Metis parents & elders who were proud of our Metis language and identity and what they learned and were taught how to survive off the land and had values like extended family, caring and sharing that provided us with knowledge, resilience, guidance and hope.

Fast forward to current Metis Engagement, Participation and Outcomes related to Land Based Resource Extraction including having five (5) active uranium mines & mills operating within the 1994 Metis Land Claim geographic area. The Cluff Lake

Uranium Mine Project occurred between 1979 – 2002 and was fully decommissioned in 2023. The Metis People and Families gained general understanding about uranium licensing processing and operations, industrial skills, jobs and some contracts. So, BN-MCC and our citizens and families have a lot of experience dealing with Uranium Mines.

Metis way of Life: “How it improved?”

Many general factors improved Metis way of life such as : 1982 repatriation of Canada Constitution and addition of Section 35; 1994 NW Sask Metis Land Claim launch; SCC Powley case 2003 Metis right to hunt in Section 35; UNDRIP 2007; 94 calls in TRC in 2015; SCC ruling in Daniels Cases in 2016 and the 2023 NexGen – CWCL NR2 Impact Benefit Agreement (IBA) ...

The largest positive impact, benefits, meaningful engagement and accommodation received BN-MCC & our Citizens to date with the Uranium Industry has been by far the “NexGen Impact Benefit Agreement between CWCL NR2 “signed by BN-MCC and the other NR2 Metis Communities, on June 15, 2023.

The formal relationship with NexGen began with BN-MCC leadership since 2019 and since then, to date this relationship has gained Trust through recognition & acknowledgement of Distinct Metis Identity, Culture and Rights; Taking action on Local Priorities such as youth leadership; scholarships; Community social & food security issues; Ethical engagement, Inclusion and Transparency throughout the process on all matters related to the Environmental Assessment and Rook 1 Project and by creating Transformational Change through strong Partnerships that supports Metis Rights and Distinct equity, employment and training needs; jobs; contracts, economic development alongwith environmental health and safety.

Buffalo Narrows Metis Citizens have raised Rook 1 Project issues related to the highway #155 transportation route corridor and particularly ones regarding trucks within our community boundary and on our Mainstreet. The three main concerns

raised are the installation of a highway traffic light for the safety of our school children crossing the main highway which is currently being mitigated through discussion with BN Municipal Council, Saskatchewan Highways and NexGen. Additionally, Prevention, Emergency Preparedness and Response has been raised within the IBA process to address the projected increase in traffic flow expected during this proposed project. The third concern is how all partners and stakeholders can work together on supporting a BN Metis Distinct Governance, Administration & Community Service infrastructure plan. BN-MCC has confidence that all these issues will be open for dialogue, fairly advanced and resolved in a timely manner to the satisfaction of all parties.

BN-MCC acknowledges and thanks those responsible, who have set a New Industry Gold Standard and Precedent by initiating & leading the creation of our NexGen-CWCL NR2 IBA and help build a space for Metis Voices, Inherent Rights, Knowledge Systems and Partnerships. This has tremendously improved Metis lives in Buffalo Narrows, supported economic reconciliation and produced pervasive influence and generational benefit.

What BN-MCC sees as success is when our Metis Citizens have achieved: a better overall education, awareness & understanding the uranium industry; a stronger partnerships with mutual benefits; a recognition and acknowledgement for decisions not to be considered as “one & done” but continuously being developed throughout the life of the mine; a team comprised of many and all focused on quality outcomes and a strong sense of Metis Community Engagement, Pride, Identity and Belonging. BN-MCC and our Citizens feel proud that we have transitioned from managing poverty to now being on the right path with support from our partners to help grow our economic system & footprint and begin to manage prosperity.

In conclusion, BN-MCC wholeheartedly supports NexGen Rook 1 Project to receive full approval for their license from CNSC to prepare a site for and to construct their proposed Rook 1, mine and mill project. NexGen has proven to BN-MCC and
