
Commission Member Document Submission

- **EA2 (caribou mitigation and offsetting plan in line with the federal recovery strategy):**
Has been submitted to CNSC staff and is currently being reviewed
- **EA3 (monitoring of adverse effects on listed wildlife species):**
CNSC staff completed technical review, comments are being considered and addressed by NexGen

Regulatory commitment reviews in progress:

- **Environmental Protection-01 (Best Available Technologies and Techniques Assessment (BATEA) for Construction Phase Effluent Treatment Report):**
Responses to CNSC staff technical comments have been submitted and are under CNSC staff review
- **Environmental Protection-02 (Update to Environmental Risk Assessment)**
Responses to CNSC staff technical comments have been submitted and are under CNSC staff review
- **Physical Design-05 (Construction Quality Management):**
The criteria have been submitted and CNSC staff determined that it has **met the closure criteria**



Financial Guarantee

- On November 7, 2025, NexGen submitted a draft financial guarantee instrument for consideration by CNSC staff and the Commission
- The draft financial guarantee amount reflects the CNSC staff accepted PDP and cost estimate
- CNSC staff recommend a licence condition requiring NexGen to submit a final financial guarantee instrument to the Commission 60 days after a decision and before any construction activities are to commence on site
- CNSC staff continue to collaborate with the Saskatchewan government on financial guarantee matters through the Memorandum of Understanding on this topic




Approach to consultation with Indigenous Nations and communities (1/2)

- The CNSC's commitment to **Reconciliation**
- The **Duty to Consult**, and where appropriate, Accommodate
- *United Nations Declaration on the Rights of Indigenous Peoples Act*
- **REGDOC-3.2.2, Indigenous Engagement**






Approach to consultation with Indigenous Nations and communities (2/2)

The CNSC's approach to consultation is mindful of the principles articulated in the ***United Nations Declaration on the Rights of Indigenous Peoples Act (UNDA)***, including **Free, Prior and Informed Consent (FPIC)**.

The CNSC is currently using the following sources of guidance on FPIC:

- *Principles Respecting the Government of Canada's Relationship with Indigenous Peoples*
- *Backgrounder: United Nations Declaration on the Rights of Indigenous Peoples Act*






Asserted or Established Indigenous and/or Treaty Rights

The Rook I Project is located in Saskatchewan's **Athabasca Basin**, within the boundaries of **Treaty 8**, the No Hoe Nénéh Ancestral Lands of Clearwater River Dene Nation, the Homeland of the Métis, and is within NuheNéné, the traditional territory of the Athabasca Denesuline, Buffalo River Dene Nation and Birch Narrows Dene Nation.





Identified Indigenous Nations and communities

CNSC staff identified the following Indigenous Nations and communities:

Timeline of Consultation and Engagement for Rook I

2019 - 2020

Opportunities for consultation began on the Rook I Project Description and EA process including opportunity to **review the Project Description** and to **comment** on the scope of the **EA decision**.

2020 - 2021

Ongoing opportunities for engagement and consultation on the EA and **participant funding** made available to review the draft EIS.

2022 - 2024

NexGen submitted draft EIS and licence application for the Rook I mine. **Federal Indigenous Review Team (FIRT)** established for draft EIS review. **Ongoing consultation and engagement activities with Indigenous Nations and communities**.

Nov 2024 –
Jan 2025

NexGen submitted Final EIS and CNSC's final review began. **CNSC accepted NexGen's final EIS**. **Ongoing consultation and engagement activities with Indigenous Nations and communities**.

2025 - 2026

Participant Funding made available to participate in the hearing process.
Consultation efforts and next steps for both EA and licence application.
November 2025 - Part 1 hearing. February 2026- Part 2 hearing.

Lifecycle consultation and engagement related to Rook I, should a licence be issued.

Consultation and engagement activities with identified Indigenous Nations and communities (1/2)

- Initial notification sent in April 2019 inviting the Nations and communities to meet and discuss the Project
- Monitoring NexGen's engagement activities in accordance with REGDOC-3.2.2
- Provided multiple opportunities for dialogue through phone calls, correspondence and meetings with Leadership and community representatives
- Offered opportunities for consultation through the EA and Licensing process
- Participating in community and cultural events

- Metis involvement in oversight and monitoring

INDIGENOUS CONSULTATION AND ENGAGEMENT: ASSESSMENT OF POTENTIAL IMPACTS ON RIGHTS



Assessment of Potential Impacts on Rights from NexGen's Rook I Application (1/3)

The Commission is required to uphold Indigenous peoples' potential or established Indigenous and/or Treaty rights.

To support the Commission's decision-making, **CNSC staff assess and make recommendations to the Commission** on the potential impacts to Indigenous and/or Treaty rights which take into account the proposed mitigations, follow-up measures, commitments and accommodations for the Project.

This assessment of potential impacts to Indigenous and/or Treaty rights is completed through a **Rights Impact Assessment**.



Assessment of Potential Impacts on Rights from NexGen's Rook I Application (2/3)

- As part of the Crown's Duty to Consult, and where appropriate, Accommodate, the Commission will consider potential impacts to Indigenous and/or Treaty rights and measures to mitigate and accommodate impacts in relation to this licensing and EA decision
- Rights Impact Assessments (RIAs) are a best practise utilized across the Federal Government for major projects and decisions that could potentially impact Indigenous and/or Treaty rights
- CNSC staff proposed conducting RIAs in response to traditional land use identified and concerns raised by Clearwater River Dene Nation, Métis Nation – Saskatchewan, and Birch Narrows Dene Nation about the potential for the Project and Commission decision to impact their Indigenous and/or Treaty rights



Assessment of Potential Impacts on Rights from NexGen's Rook I Application (3/3)

CNSC staff have been seeking and providing opportunities for discussions with Indigenous Nations and communities regarding potential impacts to their Indigenous and/or Treaty rights.

CNSC staff engaged with, and heard concerns from

- Clearwater River Dene Nation (CRDN),
- Métis Nation – Saskatchewan (MN-S),
- Birch Narrows Dene Nation (BNDN), and
- Buffalo River Dene Nation (BRDN)

regarding the potential for the NexGen Rook I project to impact their rights and interests.

CNSC staff proposed conducting collaborative Rights Impact Assessments for the EA and licensing process for three potentially impacted Nations and the RIAs evaluated how the residual impacts from the NexGen Rook I Project may interact and impact each Nation's or community's ability to exercise their rights.

Commitments and Next Steps

Proposed Key Commitments and Accommodations:

NexGen:

- Surface water and groundwater monitoring programs
- Developing and implementing a monitoring approach and the framework for results sharing
- Commit to environmental monitoring and address concerns through the Environmental Committee
- Collaborating on the decommissioning plan
- Caribou Mitigation and Offset Plan

CNSC staff:

- Proposing licence condition on Indigenous engagement
- Continuing to support Indigenous Nations and communities through long-term TORs
- Collaboration on oversight and reporting on all relevant licence conditions
- Engagement and collaboration on CNSC's Independent Environmental Monitoring Program
- Inclusion of the Rook I Project into IEMP or other Monitoring Programs



Conclusions on Potential Impacts on Rights

Analysis and Conclusions

Regarding Potential Impacts on Rights for the Rook I Project:

- CNSC staff recommend that the Commission direct CNSC staff and NexGen to implement the commitments and proposed accommodation measures as outlined in the previous slide and Appendix A of the supplemental CMD
- CNSC staff will continue to work with the identified Indigenous Nations and communities on proposed commitments including addressing outstanding concerns, where possible
- Considering all information available to date, CNSC staff's view is that the potential impacts to Indigenous and/or Treaty rights **have been appropriately considered, assessed, mitigated and accommodated**, should the Commission grant a Licence to Prepare Site and Construct

CNSC STAFF CONCLUSIONS AND RECOMMENDATIONS



Conclusions and Recommendations

33

CNSC staff conclude that NexGen will develop the Rook I project in a way that is safe.

Staff are ready to verify compliance if a licence is issued.

CNSC staff recommend that the Commission determine that:

- The Duty to Consult with and accommodate Indigenous Nations and communities has been fulfilled
- The Rook I project is not likely to cause significant adverse environmental effects
- NexGen is qualified to prepare site for and construct the Rook I project, and will make adequate provision for the protection of the environment, the health and safety of persons, the maintenance of national security, and measures required to implement international obligations
