On behalf of the Clarington Board of Trade (CBOT), I am writing in support of Ontario Power Generation Inc.'s (OPG) application to renew the Power Reactor Operating Licence for the Darlington Nuclear Generating Station, which is set to expire on November 30, 2025. We also support OPG's request for a 30-year licence renewal term extending from December 1, 2025 to November 30, 2055.

We are confident that OPG will continue to operate the Darlington facility to the highest standards of safety, environmental stewardship, and community responsibility.
