
Ya'thi Néné Lands and Resources (YNLR)

To protect the lands and waters of the Athabasca Basin for the longterm benefit of its Denesuline First Nations and Athabasca communities



Ya'thi Néné's Role

- Prior to YNLR, Athabasca communities were largely uninformed about exploration and mining projects and received little benefits
- Damage to lands and waters occurred
- Now, YNLR liaises between communities, industry, and government on projects of mutual interest and has formal agreements with multiple exploration and mining companies
- To strengthen the relationship and support the discussion of issues or concerns, YNLR and CNSC established a Terms of Reference in 2022

1. Incentive for compliance to license conditions





YNLR understands that incidents occur in complex mining and milling operations

The number of notices of noncompliance (NNC) have increased in past two years but number of inspections did not proportionally increase

- 2019, 2020, 2021: average of 18 NNC/year
- 2022, 2023: average of 86 NNC/year

2. License lengths for Cameco's Key Lake, McArthur River, and Rabbit Lake





The Athabasca Basin communities opposed license durations of 15 and 20 years for Rabbit Lake, Key Lake, and McArthur River Operations in written intervention and at Hearing in June 2023

Yet, Cameco received long license lengths; now treated as foregone conclusion

YNLR goes on record to state our opposition; instead advocated for 5- and 10-year licenses

3. YNLR's Involvement in IEMP





YNLR appreciates our involvement with the IEMP each year

- Conduct interviews to help determine sampling locations and traditional foods
- Staff participate in field work
- Residents can donate foods they want tested

In May 2024, CNSC and YNLR copresented about IEMP at Turtle Island Conference. YNLR believes the IEMP should be expanded across the Basin and is a great example of how remote Indigenous communities can work directly with regulators

4. CNSC's Response to YNLR Feedback





YNLR has provided many suggestions to the CNSC about processes that would better serve Athabasca Basin communities

CNSC response is detailed in Appendix P of the 2023 ROR, and have made many improvements

YNLR appreciates these efforts and looks forward to continued improvements
