Item One: Radiography Equipment Certification

CNSC Staff looked at the outcomes/feedback of previous CNSC initiatives regarding certification of radiography exposure devices. A regulatory guide is planned to be published for consultation on this project this spring. (Action open)

10(RWG-01) 2.0 CEDO CERTIFICATION

A presentation by industry members was made to the group on the CEDO certification process. The full presentation is included with the minutes. The following key issues were highlighted:

- 1. The written exam is not current with actual regulations and standards.
- 2. G229 is not current.
- 3. Certification process is confusing and disconnected from reality.
- 4. Training expectations of EDO are not clear.

After the presentation, it was decided that the CEDO certification would become the priority of the group.

A project team will have to be put together to work on the redesign of the training of CEDO.

We decided that discussion on equipment and notification failure would be discussed at a later date.

10(RWG-01)3.0 CNSC OUTREACH

We discussed the possibility of having a general Industrial Radiography Meeting in Nisku on May 27 and/or 28, 2010.

Ideas for this outreach meeting are:

- 1. Uniformity between inspectors (communication)
- 2. TDG workshop
- 3. Process to receive feedback from radiographers/licensee (Survey to licensees)
- 4. Equipment
