## Notice: Inadvertent Posting of Protected Information and Required Actions

Between September 24, 2024, and November 26, 2024, some documents that were the subject of requests for confidentiality were available to the public on the CNSC website. This was an unintentional error, as they were then under consideration for being treated as confidential filings. These documents were part of the hearing on the application by <u>Ontario Power Generation Inc. (OPG) for a licence to construct one BWRX-300 reactor for its Darlington New Nuclear Project</u>.

The Commission decided that some of the information merited protection from public disclosure. This *Notice* applies with respect to the protected information that was temporarily available to the public ("Protected Information"), listed below in <u>Table 1</u> and <u>Table 2</u>.

The Commission directs that the following actions be taken by any person who may have accessed or been in possession of Protected Information:

- 1. Any person in possession of Protected Information must refrain from using, disseminating or publishing the Protected Information.
- 2. Any person who is, or who has been, in possession of Protected Information, must immediately destroy the information, whether in electronic or paper form, as well as any notes on or summaries of the Protected Information that may have been made.
- 3. Any person who is, or who has been, in possession of Protected Information, and who becomes aware of this *Notice*, shall communicate this *Notice* to every other person with whom they have shared the Protected Information.
