

## Notice of Participation at a Commission Meeting and Participant Funding

Upcoming public meeting on the Regulatory Oversight Report for Uranium and Nuclear Substance Processing Facilities and Research Reactors in Canada: 2020

The <u>Canadian Nuclear Safety Commission</u> (CNSC) will hold a public meeting in December 2021, where CNSC staff will present the *Regulatory Oversight Report for Uranium and Nuclear Substance Processing Facilities and Research Reactors in Canada: 2020* (UNSPF and Research Reactors ROR). The 2020 UNSPF and Research Reactors ROR will provide an overview of CNSC regulatory efforts with respect to uranium and nuclear substance processing facilities in 2020 and research reactors from 2018 to 2020.

Date: December 15 and 16, 2021

Place: To be determined (at this time, a virtual meeting)

Time: As set by the agenda published prior to the meeting date

The public meeting will be webcast live and available on the CNSC website at nuclearsafety.gc.ca.

In advance of the public meeting, the CNSC is making available up to \$50,000 in funding through its Participant Funding Program. The purpose of the funding is to assist Indigenous peoples, members of the public and stakeholders in reviewing CNSC staff's UNSPF and Research Reactors ROR and in participating in the Commission meeting process by providing topic-specific written submissions to the Commission. Participant funding applications must clearly demonstrate how the proposed submission will provide the Commission with information directly relating to the UNSPF and Research Reactors ROR and the regulatory performance of CNSC-licensed uranium and nuclear substance processing facilities in 2020 and research reactors from 2018 to 2020. Please note that the \$50,000 will be disbursed among all successful applicants. The deadline for submitting a completed participant funding application form to the CNSC is August 13, 2021.

The UNSPF and Research Reactors ROR will be available for review on the CNSC website, or on request to the Secretariat, after **September 1, 2021**.

Persons who have an interest or expertise in these matters are invited to comment, in writing, on the UNSPF and Research Reactors ROR by **November 1, 2021**, using the <u>online request form</u> or the contact information below. The submission must include your name, address, telephone



number and email address. In addition, in the spirit of reconciliation and in recognition of the Indigenous oral tradition for sharing knowledge, the CNSC will offer Indigenous intervenors the opportunity to make oral presentations. Oral presentations will be conducted remotely.

All submissions will be available for download on the CNSC website or on request to the Secretariat. Personal information, such as address and telephone number, is essential for linking the submission to its author.
