Upcoming public meeting on two-part regulatory oversight report on the Use of Nuclear Substances in Canada: 2019 and Class IB Accelerators in Canada: 2018 and 2019

In November 2020, the Canadian Nuclear Safety Commission (CNSC) will hold a public meeting, where CNSC staff will present a two-part regulatory oversight report: Part I, Use of Nuclear Substances in Canada: 2019, and Part II, Class IB Accelerators in Canada: 2018 and 2019 (ROR). A presentation and plain-language executive summary on each of these two parts will also be presented.

Part I of the ROR will provide CNSC staff's assessment of the safety performance of licensees in the medical, industrial, academic and research, and commercial sectors that used nuclear substances in Canada in 2019. Part II of the ROR will summarize CNSC staff's assessment of the performance of the two Class IB accelerator facilities (TRIUMF and Canadian Light Source Inc.) in Canada.

The public meeting will be webcast live and available on the CNSC website at nuclearsafety.gc.ca.

In advance of the public meeting, the CNSC is making available up to **\$20,000** in funding through its Participant Funding Program (PFP). The purpose of the funding is to assist Indigenous peoples, members of the public and stakeholders in reviewing CNSC staff's ROR and participating in the Commission meeting process by providing topic-specific written submissions to the Commission. PFP applications must clearly demonstrate how the proposed intervention will provide the Commission with information directly relating to the ROR, or safety performance by nuclear substances licensees during 2019 or at the two Class IB accelerator facilities in 2018–19. Please note that the \$20,000 will be disbursed among all successful applicants. The deadline for submitting a completed participant funding application form to the CNSC is July 20, 2020.



The ROR will be available for review on the CNSC website, or on request to the Secretariat, after **August 27, 2020.**

Persons who have an interest or expertise in this matter are invited to comment, in writing, on the ROR by **October 8, 2020** using the <u>online request form</u> or the contact information below. The submission must include your name, address, telephone number and email address. In addition, the CNSC will allow Indigenous intervenors the opportunity to make oral presentations in the spirit of reconciliation and in recognition of the Indigenous oral tradition for sharing knowledge. Due to potential travel restrictions or limitations in relation to the COVID-19 pandemic, oral presentations will be conducted remotely.

All submissions will be available for download on the CNSC website or on request to the Secretariat.
