Upcoming public meeting on the *Regulatory Oversight Report on the Use of Nuclear Substances in Canada: 2018*

The Canadian Nuclear Safety Commission (CNSC) will hold a public meeting in November 2019 where CNSC staff will present the *Regulatory Oversight Report on the Use of Nuclear Substances in Canada: 2018* (ROR). The ROR will provide CNSC staff's assessment of the safety performance of licensees in the medical, industrial, academic and research, and commercial sectors that used nuclear substances in Canada in 2018, and information on the radiation doses received by workers engaged in this type of CNSC-licensed activity.

The public meeting will be webcast live and available on the CNSC website at nuclearsafety.gc.ca.

In advance of the public meeting, the CNSC is making available up to **\$25,000** in funding, through its [Participant Funding Program](#). The purpose of the funding is to assist Indigenous peoples, members of the public and stakeholders in reviewing CNSC staff's ROR and participating in the Commission meeting process by providing topic-specific submissions to the Commission. Please note that the \$25,000 will be disbursed among all successful applicants. The deadline for submitting a completed participant funding application form to the CNSC is **June 7, 2019**.

The draft ROR will be available for review on the CNSC website, or on request to the Secretariat, after **September 6, 2019**.

Persons who have an interest or expertise in this matter are invited to comment on the ROR in writing by **October 7, 2019** using the [online request form](#) or the contact information below. The submission must include your name, address and telephone number. In addition, the CNSC will allow Indigenous intervenors the opportunity to make oral presentations in the spirit of reconciliation and in recognition of the Indigenous oral tradition for sharing knowledge.

All submissions will be available for download on the CNSC website, or on request to the Secretariat.
