Actions or measures required to be taken by licensee and/or other person(s) (specify) in respect of any facility, place, substance, vehicle, equipment or information (specify), including any time limits or restrictions</b> Tavis Cameron, Jeremiah Chartier and McKinley Hyland are hereby ordered stop radiography operations and Vision Integrity Engineering Ltd. is hereby ordered to return exposure devices serial numbers S2460, S3798, S3865 which have been assigned to the McKinley subcontract (Nisku, AB and Grande Prairie, AB) to secure storage at a CNSC approved and disclosed location (Medicine Hat or Lethbridge, AB or storage at a CNSC licensed third party storage facility) until such time that: 1) the CNSC has been informed in writing, of the McKinley subcontract location(s) and the licensee can demonstrate sufficient management oversight and control of the Radiation Safety Program at the location(s). The licensee must specifically demonstrate that: a) sufficient inventory control measures (including inventory tracking, quarterly maintenance, dates & locations of use, pre-operational checks and daily DRD readings) surrounding the three (3) exposure devices have been implemented and, b) calibrated monitoring equipment has been assigned to the three (3) workers currently under the McKinley subcontract and c) the training of the three (3) workers currently under the McKinley subcontract has been completed in accordance with the licensee's established training program OR 2) Vision Integrity Engineering Ltd. has confirmed, in writing, in response to Inspection Report Index DS-16494-JGSL-241211-1 that licensed activities conducted at the McKinley subcontract location have been discontinued.

<b>5b. This order is closed when all terms listed in 5a of this form have been fulfilled, and</b> Should Vision Integrity Engineering Ltd. choose Option 2 in box 5a., the response to Inspection Report Index DS-16494-JGSL-241211-1 must demonstrate how Vision Integrity Engineering Ltd. will ensure that the company's Radiation Safety Program will be effectively implemented for any future subcontract relationships it enters into.

<b>6. Information on which order is based</b> This order is based on Inspection Report Index DS-16494-JGSL-241211-1 specifically, the licensee's failure to demonstrate that the Radiation Safety Program has been effectively administered for a subcontractor (McKinley) site that has been established in the Nisku, AB (and possibly Grande Prairie, AB) region. The site(s) have not been disclosed to the CNSC, the inventory control (including quarterly maintenance, dates & locations of use, pre-operational checks and daily DRD readings) surrounding the three (3) exposure devices is inadequate and the licensee could not sufficiently demonstrate that calibrated monitoring equipment has been assigned to and training of the three (3) workers currently under the McKinley subcontract has been met.

**37(2)(f)** The Commission may authorize a designated officer to make any order that an inspector may make under subsection 35(1) or (2).

**38** Every order of an inspector and every order of a designated officer under paragraph 37(2)(f) shall be made, and every measure under paragraph 37(2)(c), (d) or (g) shall be taken, in accordance with the *Canadian Nuclear Safety Commission Rules of Procedure*.

**COMPLIANCE WITH ORDER**

**41** Every person named in or subject to an order of the Commission, an inspector or designated officer shall, regardless of whether or not the person has had an opportunity to make representations with respect to the order, comply with the order within the time specified in it or, if no time is specified, immediately.
