## Commission Ruling on Request to Protect Confidential Information under Rule 12, *Canadian Nuclear Safety Commission Rules of Procedure*

**Requestor:** Ontario Power Generation Inc.

Matter:24-H3 — Ontario Power Generation's Application for a Licence to Construct a BWRX-<br/>300 Reactor at the Darlington New Nuclear Project

**Proceeding:** Two-Part Public Hearing, Part 1 held on October 2, 2024 and Part 2 to be held January 8-10, 2025 and January 13-14, 2025

The Commission has considered Ontario Power Generation's request<sup>1</sup> for a closed session at Part 2 of the public hearing to discuss confidential information pertaining to OPG's application for a licence to construct a BWRX-300 reactor at the Darlington New Nuclear Project (DNNP). This request was made pursuant to rule 12 of the <u>Canadian Nuclear Safety Commission Rules of Procedure</u> (the Rules).

This is the sixth request for confidentiality that OPG has submitted pertaining to information on the record for OPG's application for a licence to construct a BWRX-300 reactor at the DNNP. The Commission ruled on OPG's five previous requests in three Records of Decision issued on <u>October</u> 29, 2024<sup>2</sup>, <u>November 28, 2024<sup>3</sup></u>, and <u>December 3, 2024.</u><sup>4</sup>

The Commission's ruling on this request, for the purposes of this proceeding, is documented in Table 1 below.

Therefore, the Commission rejects OPG's request for a closed session.

The Commission has the option to hold a closed session with OPG should the Commission determine that it requires additional confidential information to make a decision. If the Commission decides to hold a closed session, it will communicate this to hearing participants as appropriate.
