CNSC to conduct a hearing in writing on the revised preliminary decommissioning plan and financial guarantee for Cameco Corporation's Port Hope Conversion Facility

The Canadian Nuclear Safety Commission (CNSC) will conduct a hearing based on written submissions in December 2023. The hearing is to consider an application from Cameco Corporation (Cameco) for the acceptance of the revised preliminary decommissioning plan (PDP) and financial guarantee for the [Port Hope Conversion Facility](#). The Port Hope Conversion Facility is located in the Municipality of Port Hope, Ontario, in the traditional territory of the Wendat, Anishinabek Nation, and the territory covered by the Williams Treaties with the Michi Saagiig and Chippewa Nations. **This revised notice of hearing in writing is to announce an extension to the deadline for interventions. Interventions are now due by December 18, 2023.**

Cameco is currently licensed to operate the Port Hope Conversion Facility. As per its licence, Cameco is required to implement and maintain a decommissioning strategy and financial guarantee, which ensures funding for its future decommissioning costs. Cameco is also required to revise its PDP and financial guarantee every 5 years.

The hearing submissions from [Cameco](#) and [CNSC staff](#) are available on the CNSC website at nuclearsafety.gc.ca or upon request to the Commission Registry. Cameco's submission refers to confidential information. Pursuant to rule 12 of the [Canadian Nuclear Safety Commission Rules of Procedure](#) (the Rules), the Commission [decided](#) to take measures to protect that information. A [summary of the confidential information](#) is available on the CNSC website or upon request to the Commission Registry.

Interventions

Pursuant to rule 19 of the Rules, persons who have an interest or expertise in this matter or information that may be useful to the Commission in coming to a decision are invited to comment, in writing, on Cameco's application. Requests to intervene must be filed with the Commission Registry by **December 18, 2023**, using the [online request form](#), by emailing the Registry at interventions@cnsccsn.gc.ca, or using the contact information below. **The request to intervene must include the following information:**

- a written submission of the comments to be presented to the Commission
- the requester's name, address, telephone number and email address

All submissions will be available for download on the CNSC website at nuclearsafety.gc.ca or upon request to the Commission Registry. Personal information, such as address and telephone number, is essential for linking the submission to its author. If you wish to ensure the confidentiality of your personal information, please submit it on a separate page.

A panel of the Commission will consider written submissions from Cameco and CNSC staff, as well as written interventions from members of the public. The Commission will then deliberate and render a decision on Cameco's application. Following the deliberations and decision of the Commission on this matter, a record of decision will be published on the CNSC website at nuclearsafety.gc.ca and made available upon request. A decision from the Commission is anticipated in January 2024.
