Memorandum of Understanding

Between

Bruce Power

and

South Bruce Grey Health Centre

and

Grey Bruce Health Services

Effective Date: April 8, 2015

BACKGROUND

- I. Bruce Power, South Bruce Grey Health Centre (SBGHC) and Grey Bruce Health Services (GBHS) have a long standing relationship and have collaborated on a wide-range of initiatives to support quality health care and emergency services in the Grey-Bruce Region. This has included investments in health care infrastructure, physician recruitment and retention activities along with a wide-range of health initiatives.
- II. The South Bruce Grey Health Centre (SBGHC) serves a community of approximately 44,000 people, plus 10,000 seasonal residents and 30,000 tourists across four rural hospital sites located in Chesley, Durham, Kincardine and Walkerton. SBGHC employs a staff of close to 400 people and all sites offer 24-hour emergency care. Other services include acute, coronary care, obstetrical, surgical and a full range of diagnostic and ambulatory care services.
- III. Grey Bruce Health Services (GBHS) is an integrated multi-site acute care public hospital organization. Its hospitals in Owen Sound, Southampton, Markdale, Meaford, Wiarton and Lion's Head and its Withdrawal Management & Addictions Services facility in Owen Sound serve an immediate permanent population of about 106,000 people in northern Grey and Bruce counties, in addition to thousands of seasonal residents and well over 2 million short stay visitors annually. In addition, the Owen Sound regional hospital serves as the secondary care centre for all of Bruce and Grey Counties; a largely rural region with an overall population of 160,000.
- IV. Bruce Power operates the world's largest operating nuclear generating facility and is the source of roughly 30 per cent of Ontario's electricity. The company's site is in Tiverton, Ontario. Formed in 2001, Bruce Power is an all-Canadian partnership among Borealis Infrastructure Management (a division of the Ontario Municipal Employees Retirement System), TransCanada, the Power Workers' Union and the Society of Energy Professionals. A majority of Bruce Power's 4,200 employees are also owners in the business and mostly reside in Grey, Bruce and Huron Counties.
- V. In 2013, Bruce Power announced \$2 Million in funding to support the enhancement of health care infrastructure within GBHS and SBGHC with a particular focus in the Kincardine and Southampton hospitals. In addition, Bruce Power has provided over \$500,000 in funding to

support physician recruitment from 2010-2013 in Kincardine and Saugeen Shores and continues to fund this initiative jointly with the Municipality of Saugeen Shores and Kincardine. The company has also committed to ongoing annual funding supporting a range of regional health initiatives through its Community Investment & Sponsorship Program.

- Bruce Power, GBHS and SBGHC continue to share a commitment to enhance health care within VI. the region and collaborate to ensure emergency services are available generally in the region with a focus on emergency preparedness and training.
- Bruce Power has announced \$150,000 in funding for GBHS and SBGHC to support one-time VII. investments to enhance emergency preparedness training and equipment throughout 2015 and 2016.

The parties accept the following non-binding Memorandum of Understanding.

PURPOSE

The purpose of this MOU is provide a framework in which Bruce Power, GBHS and SBGHC can build on their successful working relationship over the last 14 years and identify new areas of collaboration with a particular focus on improving regional health care and enhance emergency services.

AREAS OF COOPERATION

The parties endeavour to collaborate with each other to develop and implement the following objectives:

- invest in hospital infrastructure, including facility enhancements, diagnostic equipment, and specialized instrumentation;
- improve emergency preparedness through training of staff, participation in drills and exercises, and maintenance of an integrated response plan;
- ensure alignment and collaboration to new regulatory requirements related to the pre-distribution of KI Pills.
- continue physician recruitment initiatives with surrounding municipalities to bring new emergency room and family doctors to the region;
- support health and wellness programs;
- sponsor public health education and awareness campaigns; and
- strengthen cooperation through a knowledge partnership, including research and information sharing in the areas of common interest.

ENGAGEMENT & REPORTING

Bruce Power, GBHS and SBGHC will continue to engage to advance these areas of co-operation and a joint steering committee will meet as needed to align and advance these various issues. The steering committee will consist of Bruce Power's Vice-President Corporate Affairs, and the President and CEO of both GBHS and SBGHC, and/or their designates.

Bruce Power will chair the joint steering committee, and provide administrative support to the committee.

This MOU will be made available to the public on the websites of Bruce Power, GBHS and SBGHC and an annual report will be published each year on the progress made between the organizations.
