



The submission is in support of the application for 10-year operating licence renewal at Bruce Power.

Bruce Power is an engaged member of the local Opioid Working Group (a working group of the Community Drug and Alcohol Strategy). The Opioid Working Group brings together a variety of community partners to form a local response to the current opioid crisis. Bruce Power has long been a partner in child and youth safety initiatives. They have, in the past, participated in support of car seat programs, bike helmet promotion, SMARTRISK injury prevention programming in schools and the Children's Safety Village at Saugeen Valley Conservation Authority.

In the area of youth dental health, Bruce Power has funded to oral health awareness programs in the schools and in a promotion encouraging students to drink water rather than sweetened beverages.

Bruce Power assists the recreation and physical activity needs of our communities. They contribute to the Longest Day of PLAY. This event raises awareness of the importance of daily physical activity and encourages residents to get more active. The Longest Day of PLAY has proven so popular locally it has been adopted by ParticipACTION as a national event. Bruce Power has also provided significant financial assistance for community recreation facilities in Owen Sound, Hanover and Port Elgin.

In the area of emergency planning, the development and publication of the booklet *Be Prepared Grey/Bruce/Huron Your personal guide for community safety* is a valuable resource to assist residents in to prepare for and respond to a broad range of emergencies. Bruce Power's commitment to emergency planning is also demonstrated in the rigor of annual testing of their plans and procedures in responding to a nuclear emergency including supporting the specific public health roles outlined in the Radiation Health Response Plan.
