

The CNWC indicated in it's written submission of April 16 that we had coordinated an on line petition in support of Bruce Power. Please accept this petition as part of the formal submission of the Canadian Nuclear Workers Council, in support of Bruce Power's 10-year Licence Renewal application.

Seven organizations – the Bruce Power Pensioners Association, Canadian Nuclear Workers' Council, the Grey Bruce Labour Council, North American-Young Generation Nuclear, the Power Workers' Union, The Society of United Professionals, and the Bruce Chapter of Women in Nuclear-Canada – joined forces to launch an online petition to gather support for Bruce Power's licence renewal. The response has been overwhelming, with nearly 10,000 signatures. The petition is included with this letter.

We believe Bruce Power's role in Ontario electricity sector has never been more important. The company safely provides 30% of Ontario's electricity at 30% less than the average residential cost of power – keeping bills low for families and businesses – while also providing jobs for 4,200 full-time workers, including many of those in our member organizations. Bruce Power's impact reaches much further than the Lake Huron shoreline though, as its ongoing operations injects over \$4 billion directly and indirectly into Ontario's economy every year, while creating and sustaining 22,000 jobs annually.

Bruce Power will have a long-term, positive impact on Bruce, Grey and Huron counties, suppliers, local communities and the entire province, now and for future generations.

In addition to operating safely, Bruce Power also helps keep our air clean, generating no carbon emissions from the production of its energy, while also providing 70% of the electricity Ontario needed to shut down its coal-fired facilities. The result has been the elimination of smog days in Ontario, healthier air for our families to breathe, and a head start for the province and country as they work toward achieving their Climate Change Action Plan goals.

These reasons are why thousands of people gave Bruce Power their support through our petition. We support Bruce Power's 10-year Licence Renewal application and urge the Canadian Nuclear Safety Commission to do the same.
