

 Located under 20 km from the Pickering nuclear plant




The Problem: Unequal Levels of Student Safety

- * Since 2016 KI tablets have been pre-stocked in the all schools within 50 km of the Bruce nuclear station.
- * Parents have also been provided information on the potential need to administer KI in the event of an accident.



Equal Protection for Toronto Students

- * There are over TDSB 580 schools with **250,000** students
- * 196 TCDSB schools with over **85,000 students**
- * 11 Conseil scolaire catholique MonAvenir Toronto-area schools
- * 7 Conseil scolaire Viamonde Toronto-area schools
