Dear Commissioners,

The State exists to provide the population with everything that each person cannot guarantee for themselves. When I notice that an aging Pickering nuclear facility was so near to my family and friends, I felt a deep concern that motivated me to write this letter. I arrived in Toronto less than a year ago and even when I do not have much time left, I do have many loved ones here that matter to me. And because of that I am worried about their well-being. OPG must to stop the operation of this Pickering Nuclear Power Station because the welfare of Canadians has already been affected because this nuclear station is located beside Lake Ontario, something that is affecting the temperature of water. The fish die-off in the lake had scandalous figures last year, I prefer don't imagine the effects that an accident could created since this nuclear power station is Toronto's drinking water resource.

It is not fair to put so many lives at risk for a plant that can and should be turned off. Canada is known internationally for its great energy production, to the point that it even exports energy to other countries. Canada does not need this type of energy to subsist and in case something goes wrong the economic cost and human lives are unimaginable.

Even if there is a real need for energy, there are other green energies that, in addition to meeting the demand for energy, provide more tranquility and security to people in their surroundings. I do not want another Chernobyl to take place in Canada, I believe that there is much to learn from the mistakes of the past.

Chernobyl shares many characteristics with the Pickering nuclear plant, the variable number of reactors and the antiquity of its facilities.
