Subject: Request to Extend the Validity Period of Certification Examinations for at Point Lepreau Nuclear Generating Station (PLNGS)

The purpose of this letter is to request an extension of the validity period for Certification Generals and Specifics examinations for while undertaking the Control Room Operator In Training (CROIT) program, in accordance with Licence Condition 2.3 Personnel Training of the LCH-PR-17.00/2022 R001 and as per Regulatory Document RD-204, Certification of Persons Working at Nuclear Power Plants, Subpart A Section 23.

As per Regulatory document – RD-204 Subpart A Section 23.3.1 on General Examinations, and 23.3.2 on Nuclear Power Plant – Specific examinations, completed his exams on the dates listed below:

Generals Exam – January 30, 2015 Specifics Exam – February 26, 2016

As per RD-204 Subpart F – Section 30.0 – Extending the Validity Period of Certification Examinations, as per Section 30.1 Conditions for Extension, items 1 and 4 apply for co-piloting was delayed due to sickness and also required to re-take the Simulator-based training component of the certification training program. PLNGS is requesting a deviation from RD-204 Subpart F – Section 30.0 – Extending the Validity Period of Certification Examinations, Section 30.1 Conditions for Extension to meet the intent of the three year extension allowed by the new RegDoc 2.2.3 volume III Subpart F – Section 30.0 – Extending the Validity Period of Certification Examinations, as per Section 30.1 Conditions for Extension. This request for an extension of three years on each of the Generals Exam, and the Specifics Exam would establish new Validity period for

has completed all requirements of the certification training program, program remediation since completion of Specifics program and is currently completing 480 hours of co-piloting. PLNGS is confident that has the knowledge and skills to safely perform the duties of a CRO despite the contravention with RD-204.

Based on the information provided, PLNGS requests that the Commission grant a onetime exemption to RD-204 Subpart F – Section 30.0 – Extending the Validity Period of Certification Examinations to allow the candidate to successfully complete the CROIT program. PLNGS believes that providing this one-time exemption will not result in any increased risk to the environment, to the health and safety of persons, or to national security, nor will it affect the international obligations to which Canada has agreed. Please confirm the extension of the exam validity period for these examinations.

Station Specifics knowledge must be used during the Simulator Examinations, as receiving a clear pass this demonstrates he has retained Station Specifics knowledge.
