Re: BWXT licence request to process uranium in the City of Peterborough.

As a Human Being and resident of Peterborough, I demand that Canada's nuclear regulator responsible for licensing nuclear power plants in Canada do <u>NOT</u> grant a licence to process uranium into fuel pellets in the City of Peterborough to BWXT.
