# LAND ACKNOWLEDGEMENT

To begin, we would like to acknowledge that the land where we live and work, on which these proceedings will be taking place, and which will be affected by the actions of the CNSC and BWXT, is the traditional and current territory of the Michi Saagiig Anishinaabeg, who are its original caretakers and knowledge holders. We offer our gratitude to these First Peoples for their care for and teachings about the Earth and our Relations. As guests in the Territory, we have a responsibility: to listen to the people and protocols of this place; to support the care and perpetuation of the life that is this land; and to recognize the culture and language of this land as guides for our work in the region. May we honour those teachings, relations, and responsibilities.

We also acknowledge and honour the Nation-to-Nation treaties which cover these territories. Nogojiwanong/Peterborough area is under the Williams Treaty (1923) and Treaty 20 (1818) and Minissing/Toronto is under Treaty 13 (1805). We recognize that these treaties are agreements between settler peoples, represented by the Crown, and the First Nations whose land this is. We must uphold our responsibilities as Treaty people and honour the rights of the First Nations laid out by these treaties and relationships.

As Treaty people, with the Crown as our representative, we ask that you apply the meanings of these land and treaty acknowledgments throughout this process, your lives, and work. We must all put our words into actions.

## WHO WE ARE AS INTERVENERS

We, the individuals who are involved in putting together and/or supporting this intervention, fully acknowledge our presence in Michi Saagiig territory, as guests. Accordingly, we feel it is our duty to uphold in true honour, the responsibilities bestowed upon us, as Treaty people.

## We support:

- True and honourable acts of reconciliation
- Respecting Nation-to-Nation relationships
- Aboriginal and treaty rights under Section 35 of the Constitution Act, 1982
- Decolonization
- Canada's implementation of all 94 "Calls to Action" put forth by the Truth and Reconciliation Commission of Canada
- Canada's implementation of the United Nations Declaration on the Rights of Indigenous Peoples

As Treaty people, we feel that it is our responsibility to support the Crown and their representatives, in their commitment to act with honour in their relations with all Indigenous peoples. As such, we will call upon the Crown's accountability, if and when, we witness this honour not being upheld. Please find below a list of our concerns, questions and conclusion in relation to BWXT NEC's request for a license renewal.

## **TERMINOLOGY**

Indigenous peoples: includes all Indigenous groups, communities and individuals.

CNSC: Canadian Nuclear Safety Commission BWXT NEC: BWXT Nuclear Energy Canada Inc.

BWXT Canada: BWXT Canada Ltd. PAR: Progressive Aboriginal Relations

#### **CONCERNS**

**We are concerned** ...that CNSC, as an agent of the Crown, is not properly fulfilling its duty to consult with its treaty partners within the Michi Saagiig territory.

We are concerned ... that CNSC appears to have the sole authority to decide if the duty to consult applies or not, for all nuclear activities in Canada. In the case of this particular license renewal, it is shocking that the duty to consult was not triggered, despite BWXT NEC's request to bring pellet manufacturing to the Nogojiwanong/Peterborough facility. The pellet manufacturing process will significantly increase the release of uranium into the air and waters of this territory.

**We are concerned** ...that CNSC is not respecting nor adhering to the Consultation and Accommodation protocols put forth by communities like Alderville, Hiawatha and Curve Lake First Nations.

**We are concerned** ...that CNSC and BWXT NEC confuse "consultation and/or engagement and/or accommodation" with "consent".

**We are concerned** ...that CNSC and BWXT NEC interpret the lack of response to communication efforts, about license renewal and changes, as "consent".

**We are concerned** ...that without the duty to consult, there is very little pressure put on BWXT NEC, by CNCS, for any significant engagement with Indigenous peoples.

We are concerned ...about ALL Indigenous peoples, whose traditional territories are occupied by the various sectors of the nuclear industry. These sectors include mines, refineries, processing facilities, power plants, waste storage sites, etc......The CNSC regulates all of these activities and we question the CNSC's commitment to meaningful consultation and engagement with ALL Indigenous peoples in these territories.

**We are concerned** ...that BWXT NEC is a brand new company and has had very little time to develop any meaningful relationships with Indigenous peoples of this territory.

# QUESTIONS

- 1. Have all or any of the Williams Treaty communities received "Notice of Request to Consult", from BWXT NEC or CNSC, as outlined in some of the community's consultation protocols, for this current license renewal?
- 2. Was the duty to consult triggered in 2010, when an amendment was made to this same license, to assemble low-enriched uranium fuel bundles, at the Nogojiwanong/Peterborough facility?
- 3. When has the "duty to consult" been formerly triggered by the CNSC, anywhere in Canada? Did CNSC and/or its proponents receive "consent" from the Indigenous peoples involved?
- 4. What exactly are BWXT's responsibilities for engagement, if the "duty to consult" is not triggered?
- 5. What kind of consultation took place when the GE facility in Nogojiwanong/Peterborough, first became a class 1B nuclear facility (60+yrs ago)? If there was no consultation, what kind of processes have since been put in place, for Indigenous peoples, to speak to (and possibly oppose) the very presence of nuclear facilities in their territory?
- Question #5 can be asked again, in relation to the Pickering and Darlington nuclear power plants, which were built in the 1970s and 1980s respectively. These plants are still in operation within the traditional territory of Michi Saagiig peoples.
- 7. What policies and procedures have changed for CNSC, BWXT Canada, BWXT NEC, since the recent Williams Treaty First Nations settlement agreement? A significant outcome of this settlement was the renewed recognition of treaty rights for this territory. An apology was given by the Crown to the Williams Treaty Indigenous peoples, admitting the Crown's dishonour.
- 8. Is BWXT, BWXT Canada and BWXT NEC aware of the Williams Treaty First Nations settlement agreement?
- 9. What role do Indigenous peoples play in helping CNSC determine regulations for the nuclear industry? Is there a consultation process in place for receiving Indigenous consent for these regulations?
- 10. Has CNSC and/or BWXT NEC reached out to any First Nation band councils?
- 11. Has CNSC and/or BWXT NEC consulted or engaged with Indigenous peoples living in Nogojiwanong/Peterborough?
- 12. Has BWXT NEC created and implemented land acknowledgement protocols for use by all levels of management and/or staff members? Such protocols should be appropriate and

pertinent to all territories where BWXT meetings might be taking place, anywhere on Turtle Island (North America)

- 13. Do any of the employees that make up CNSC's Indigenous Relations Team, identify as Indigenous?
- 14. Do any members of BWXT Canada's PAR committee identify as Indigenous?
- 15. Do any members of BWXT NEC's Community Liaison Committee identify as Indigenous?

#### CONCLUSION

We ask that the Canadian Nuclear Safety Commission NOT renew BWXT NEC's Class 1B Nuclear Fuel Facility Operating Licence, on the grounds that proper Indigenous consultation and engagement have not taken place.

## **GRATITUDE**
