Dear President and Commission Members,

My name is Jordan Coventry, and I am a Cameco employee with 14 years of experience at the Blind River Refinery (BRR). I am the Lead Technologist at the refinery and am lucky to work in a very diverse environment. My role involves managing the day-to-day activities in our engineering department, overseeing our non-destructive testing program, as well as working with various governing bodies and local contractors. Over the years I have been able to work on many continual improvement and sustainment projects which have exposed me to all areas of the process and the physical refinery.

It has been my experience that Cameco as a corporation, goes above and beyond to promote personnel safety, limit environmental impact, maintain employee engagement, support local communities, and promote a healthy work/life balance. The BRR is no exception to this rule, and actively incorporates these key principles into everyday operations.
