I am writing you today in my capacity of Chair of the Board of the St. Joseph's Foundation of Elliot Lake (the Foundation), and in support of the Cameco Bind River refinery's application for license renewal.

The St. Joseph's Foundation is a registered charitable organization, dedicated to improving patient care and patient comfort at the St. Joseph's General Hospital, St. Joseph's Manor and the Oaks Treatment Centre in Elliot Lake.

Cameco is a significant regional employer and has consistently proven themselves to be an excellent 'corporate partner' in Blind River and the surrounding municipalities. For example, several years ago the Foundation applied to Cameco's 'Giving Campaign' for financial support for an equipment purchase. Not only did the employees commit to making the Foundation a beneficiary of this program, but ultimately raised 100% of the funds needed.
