Dear President and Commission Members,

The Northumberland Manufacturers' Association (NMA) is a not-for-profit association representing 70 manufacturers with a collective 4,000 employees from across Northumberland for the past 17 years.

We are writing today to provide our full support for Cameco Fuel Manufacturing's application to renew their licence for 20 years.

As much as the NMA are a collaborative advocate and are leaders in our industry, we also depend on individual business partnerships with our local stakeholders to ensure the future health of the manufacturing industry and that its skilled people continue to thrive.

We believe that Cameco is an important stakeholder in our community; from their role in the supply of clean, safe electricity, to funding community programs and in the sharing best practises within industry, Cameco is an integral part of our economic and community success.

Locally Cameco is one of our largest employers of skilled workers, providing above living wages, growth opportunities, and is a leader in health & safety. You couldn't find a better employer in our County.

We are proud to say that there isn't a community throughout Northumberland where you don't see Cameco's support and influence. They are top notch corporate citizens.

We believe in clean, safe nuclear energy to power our industry advancement and we see this first-hand at Cameco – whether it be their leading safety record, a strong skilled workforce or the dynamic training and principles that they live by – Cameco is the company and employer you want to manage our Province's clean, reliable and safe nuclear energy.
