Commission Ruling on Request to Protect Confidential Information under Rule 12, *Canadian Nuclear Safety Commission Rules of Procedure*

Requestor: Nordion (Canada) Inc. (Nordion)

Matter: 25-H6—Ruling on request to take measures to protect information in relation to Nordion's application for licence renewal

Proceeding: Public Hearing to be held on [June 4-5, 2025](#)

With respect to the matter noted above, the Commission has considered Nordion's [request for confidentiality](#)¹ for the following documents. This request was made pursuant to subrule 12(1)(b) of the [Canadian Nuclear Safety Commission Rules of Procedure](#) (the *Rules*).

In its consideration of Nordion's request for confidentiality, the Commission also considered [CNSC staff's review](#)² of Nordion's request.

The Commission's ruling on this request, for the purposes of this proceeding, is documented in Table 1 below.

The Commission finds that, in accordance with subrule 12(1)(b) of the *Rules*, the documents listed in Table 1 contain confidential information of a financial, commercial, technical, personal or other nature that is treated consistently as confidential and that the person affected has not consented to the disclosure.

The Commission also finds that, as per subrules 12(2)(a) and 12(2)(b) of the *Rules*, protection of the information outweighs in importance the public interest in public hearings and disclosure of evidence, and the measures are designed so as not to affect the public nature of the proceeding except to the extent necessary to adequately protect the information.

In other words, the Commission is satisfied that the information available to the public in the summary or redacted versions of the documents is sufficient to satisfy the public interest. The summaries or redacted versions of the documents are available on request to the Commission Registry.

Therefore, applying subrules 12(3)(b) and 12(3)(c) of the *Rules*, the Commission orders that the publication and disclosure of information given to the Commission in items 1 to 18 be prohibited, as described in Table 1.
